

Prof. Mohammed Daud Miraki

I was born on January 23, 1967 in Kabul, Afghanistan. My family and I are from Maidan Province in Afghanistan. I lived up to the age of 5 in Kabul and thereafter, my father General Miraki was appointed the Intelligence Chief of south and south western Afghanistan, stationed in Kandahar. I enrolled in elementary school there and I studied up to grade 6 in Kandahar. After grade 6, we moved back to Kabul, where I completed grades 7 and 8. When I enrolled in grade 9, the Russians and the communists found out that my father, General Gholam Sediq Miraki, was leading the underground resistance movement in Kabul, hence, destroying the KGB from within. Before the Russians could arrest my father, we left Kabul and became refugees to Pakistan in 1982. There I completed grade 9 of high school in the Afghan Refugees School- Sayed Jamal-Udin Afghan Lace. After my father was targeted by KGB hit squads in Pakistan, we moved to Germany in 1983. In Germany I enrolled in 10th grade at a school in Marburg , Germany.

In 1984, we moved to the United States. I completed my high school diploma from Senn High School in Chicago, in May, 1986. While suffering from severe financial problems, my parents encouraged me to pursue education. I enrolled at the University of Illinois at Chicago, where I started to study biology; however, the situation in my homeland, Afghanistan compelled me to change major, rather late during my study, from biology to Political Science. The reason for the change from biology to political science was due to my desire to contribute to the betterment of Afghanistan and even dreamed of leading my homeland one day. I graduated with BA in political science in 1992.

In fall 1992, I enrolled in the Masters of Arts program in political science. In may 1993, I graduated with Masters of Arts in political science. In September 1995, I entered the Masters of Arts program in Middle Eastern Studies at the University of Chicago. In May 1996, I graduated with Masters of Arts in Middle Eastern Studies from the School of Social Sciences at the University of Chicago. In fall 1996, I entered the PhD program in public policy analysis at the University of Illinois. In July 2000, I graduated with PhD in public policy analysis in urban planning and policy with specializations in socioeconomic development & international development. I wrote my PhD dissertation on the underdevelopment issues in Afghanistan. The title of my PhD dissertation is: ' Factors of Underdevelopment in Afghanistan, 1919-2000'.

I taught management and policy courses for over three years at Chicago State University, until the college conspired to exclude me for political and religious views.

Subsequent to the US invasion of Afghanistan, I devoted myself and started data collection on the disaster of depleted uranium/non-depleted uranium in Afghanistan.

Currently, I opened a non-for-profit organization with goals to raise funds to initiate some DU clean up projects, relocate villagers from bombed villages, and provide clean water and other basic sustenance for the poor people of Afghanistan.
